Assistant Superintendent Jan Dreier reported to the Board on departmental items of significance:

- Silicon Valley Reads will be reading two books having to do with the effects of WWII on the residents of Silicon Valley.
- CCOC over the past weeks has been having "bridge to college" activities. Community
  Colleges represented by Evergreen, Mission College, and West Valley have visited
  CCOC to give students information on careers, college degrees, how to enroll and
  financial aid. The CCOC counselor is helping students to fill-in financial aid applications.
- MAEP has received notice that they will receive their federal grant money, up to 1 million+, all tied to student accountability.
- This is the 150<sup>th</sup> anniversary of adult education in California; adult education is sponsoring open houses this month.
- Dr. Willard Daggett will be at the County Office of Education on March 7 from 4:00 7:00.
- Culinary Arts student, Angelica Robles, is a finalist in Johnson and Wales competition.
   The winner is eligible for a four-year scholarship valued at \$85,000.

Superintendent Tim Hallett reported recent significant information to the Governing Board on topics not on the agenda:

- Superintendent Hallett highly encouraged Members to attend the Willard Daggett presentation at the County Office of Education on March 7. MetroED will pay the registration fee; contact Joyce and she will make the reservation.
- Sacramento: The Governor has proposed two facilities bonds. Superintendent Hallett and CBO Paul Hay has begun working with Rick Simpson to determine what cut of the \$100 million CCOC might be eligible for. Hallett and Hay have been visiting legislators about how to qualify. We are also speaking to the Governor's Office about the additional 1.8 billion and 1.4 billion funding which requires matching funds and is a competitive bid process; matching funds is impossible for CCOC to obtain.
- Superintendent Hallett presented before the Senate Education Committee in Sacramento
  on January 18. He spoke about CTE model programs. Senator Scott is a proponent of
  CTE and is opening the dialogue. At this time it is difficult to say what the outcomes will
  be. At this time the Governor is giving the CTE support to the Community Colleges and
  ROCPs are not included. We need to take full advantage of working the legislators this
  year while there is an open window of opportunity for modernization funds.
- On Tuesday, Superintendent Hallett presented at the Los Gatos-Saratoga Board meeting and introduced the new CCOC programs along with follow-up survey and other demographic information. Hallett expressed that he would welcome and invitation from other districts to make presentations about CCOC and MAEP for San Jose Unified and Campbell.
- Superintendent Hallett thanked Richard Garcia for serving as President of the Governing Board and welcomed Cynthia Chang as the newly elected Governing Board President.
